Sustainable development and international economic cooperation: implementation of and follow-up to major consensus agreements on development

Indonesia*: draft resolution

Implementation of the commitments and policies agreed upon in the Declaration on International Economic Cooperation, in particular the Revitalization of Economic Growth and Development of the Developing Countries, and implementation of the International Development Strategy for the Fourth United Nations Development Decade

The General Assembly,

Reaffirming the importance and continued validity of the Declaration on International Economic Cooperation, in particular the Revitalization of Economic Growth and Development of the Developing Countries, contained in the annex to its resolution S-18/3 of 1 May 1990, and the International Development Strategy for the Fourth United Nations Development Decade, contained in the annex to its resolution 45/199 of 21 December 1990,

Recalling its resolutions 46/144 of 17 December 1991, 47/152 of 18 December 1992, 48/185 of 21 December 1993, 49/92 of 19 December 1994 and 51/173 of 16 December 1996 on the implementation of the Declaration and the Strategy,

Recalling also the Agenda for Development,¹ as well as the results, as agreed, of all major United Nations conferences and summit meetings held since the beginning of the 1990s,

1. Takes note of the report of the Secretary-General on the implementation of the commitments and policies agreed upon in the Declaration on International Economic

Cooperation, in particular the Revitalization of Economic Growth and Development of the Developing Countries and the implementation of the International Development Strategy for the Fourth United Nations Development Decade;²

- 2. *Recognizes* the need to strengthen the implementation of the Declaration and the Strategy in the remaining years of the 1990s;
- 3. Requests the Secretary-General, in consultation with all the concerned organs and organizations of the United Nations system, including the Bretton Woods institutions, as well as other relevant international organizations, to submit to the General Assembly at its fifty-fourth session, for its consideration, an analytical report containing a thorough evaluation of the implementation of the commitments and policies agreed upon in the Declaration and the implementation of the Strategy, including the progress made and constraints therein;
- 4. Decides to include in the provisional agenda of its fifty-fourth session an item entitled "Sustainable development and international cooperation: implementation of the commitments and policies agreed upon in the Declaration on International Economic Cooperation, in particular the Revitalization of Economic Growth and Development of the Developing Countries, and the International Development Strategy for the Fourth United Nations Development Decade, and preparation and elaboration of an international development strategy for the Fifth United Nations Development Decade".
