Elaboration of an International Convention to Combat

Desertification in Those Countries Experiencing

Serious Drought and/or Desertification, particularly

in Africa

The General Assembly,

Recalling its resolutions 47/188 of 22 December 1992, 48/191 of 21 December 1993, 49/234 of 23 December 1994 and 50/112 of 20 December 1995 related to the elaboration of an International Convention to Combat Desertification in Those Countries Experiencing Serious Drought and/or Desertification, particularly in Africa,

Recalling also the United Nations Convention to Combat Desertification in Those Countries Experiencing Serious Drought and/or Desertification, particularly in Africa, $\underline{1}/$

Recalling further its resolution 50/114 of 20 December 1995, in which it recalled the decisions of the United Nations Conference on Environment and Development set forth in chapter 12 of Agenda 21, entitled "Managing Fragile ecosystems: combating desertification and drought",

Noting the ongoing work in preparation of the first session of the Conference of the Parties to the Convention undertaken by the Intergovernmental Negotiating Committee for the Elaboration of an International Convention to Combat Desertification in Those Countries Experiencing Serious Drought and/or Desertification, particularly in Africa,

Noting with satisfaction that to date more than fifty countries have already ratified the Convention,

Recalling that, in accordance with article 22, paragraph 4, of the Convention, $\underline{1}$ / the first session of the Conference of the Parties shall be convened by the interim secretariat of the Convention and shall take place not later than one year after the date of entry into force of the Convention,

<u>Having considered</u> the recommendations and decisions made by the Intergovernmental Negotiating Committee at its eighth and ninth sessions regarding the Conference of the Parties to the Convention, $\underline{2}/$

<u>Having considered also</u> the report of the Secretary-General on the implementation of General Assembly resolution 50/112 of 20 December 1995 $\underline{3}/$ and on possible requirements for intergovernmental and secretariat work on the implementation of the Convention and its regional implementation annexes to respond effectively to the needs in the African, Asian and Latin American and the Caribbean regions,

<u>Considering</u> that the Convention is one of the most important achievements in the implementation and follow-up of the recommendations and decisions of the United Nations Conference on Environment and Development, held in Rio de Janeiro in June 1992,

<u>Taking into account</u> the basic provisions of General Assembly resolution 40/243 of 18 December 1985;

- 1. <u>Welcomes</u> the fact that, in conformity with article 36, paragraph 1, of the United Nations Convention to Combat Desertification in Those Countries Experiencing Serious Drought and/or Desertification, particularly in Africa,, the Convention will enter into force on 26 December 1996, and calls upon more countries to take appropriate action for the ratification, acceptance, approval or accession to the Convention;
- 2. <u>Urges</u> the Intergovernmental Negotiating Committee for the Elaboration of an International Convention to Combat Desertification in Those Countries

Experiencing Serious Drought and/or Desertification, particularly in Africa, to continue at its tenth session, to be held from 6 to 17 January 1997 in New York, its plan for the preparatory work for the first session of the Conference of the Parties to the Convention;

- 3. <u>Decides</u> to convene, as necessary, before the first session of the Conference of the Parties to the Convention, in 1997, a further session of the Committee, of up to two weeks' duration, the exact dates and venue of which shall be determined by the Committee at its tenth session;
- 4. <u>Decides also</u> that the first session of the Conference of the Parties to the Convention shall be held for two weeks in October 1997;
- 5. Accepts with deep appreciation the generous offer of the Government of Italy to host in Rome, at the Headquarters of the Food and Agriculture Organization of the United Nations, the first session of the Conference of the Parties to the Convention;
- 6. <u>Decides</u> to include the first session of the Conference of the Parties to the Convention and the meetings of its subsidiary bodies in the calendar of conferences and meetings for 1997-1998;
- 7. Requests the head of the interim secretariat to continue to promote cooperation and coordination with other relevant organizations and entities, particularly those of the United Nations system, in support of the regional implementation annexes, aimed, inter alia, at facilitating timely financial and technical assistance to affected developing country parties, particularly those in Africa, to enable them to fulfil their commitments under the Convention;
- 8. <u>Urges</u> all States, the United Nations system, including international financial institutions and all other relevant organizations and actors, to take concrete actions and measures for the full and effective implementation of the provisions of Intergovernmental Negotiating Committee resolution 5/1 of 17 June 1994 on urgent action for Africa, 4/ as well as to promote actions for other affected developing countries and regions;
- 9. <u>Notes</u> the arrangements and contributions made by the Secretary-General and relevant organizations, funds and programmes active in the fields of desertification and/or drought;
- 10. <u>Takes note with appreciation</u> of previous contributions made and calls for additional contributions to the extrabudgetary funds established pursuant to General Assembly resolution 47/188 to assist all developing countries affected by desertification and drought, in particular the least developed countries, to participate fully and effectively in the negotiating process and in the sessions of the Conference of the Parties to the Convention and its subsidiary bodies;
- 11. Renews its appeal to Governments, regional economic integration organizations and other interested organizations, as well as to non-governmental

organizations and the private sector, to continue to make contributions to relevant United Nations bodies, in order to strengthen their capacity to support activities to combat desertification and/or mitigate the effects of drought in all affected developing countries and regions, particularly in Africa;

- 12. <u>Requests</u> the Secretary-General, in the context of the relevant United Nations programme budget for the interim secretariat of the Convention, to continue to provide support to it until 31 December 1998, and to maintain the above-mentioned extrabudgetary funds;
- 13. <u>Requests</u> the Secretary-General to bring the present resolution to the attention of all Governments, the relevant specialized agencies, funds and programmes of the United Nations system, international financial institutions, other intergovernmental and non-governmental organizations and relevant institutions;
- 14. <u>Also requests</u> the Secretary-General to report to it, at its fifty-second session, on the implementation of the present resolution and on any possible implications arising from the report of the Conference of the Parties to the Convention on its first session;
- 15. <u>Decides</u> to include in the provisional agenda of its fifty-second session an item entitled "Implementation of the United Nations Convention to Combat Desertification in Those Countries Experiencing Serious Drought and/or Desertification, particularly in Africa".
